Daycare Consent Agreement

**As a Condition of using our Services for your Pets, the following
Daycare Consent Agreement must be Initialed and Signed.**

By choosing to utilize the services, participate in daycare activities, boarding and/or grooming my pet(s) at **Paws At Play Resort & Daycare**, I agree to the following: **(Please initial each statement.)**

1. _____ I agree to pay the rates that are in effect at the time my pet is at **Paws At Play Resort & Daycare**. I am aware that extra charges may be incurred and I agree to pay them at the time of pick-up. Examples include, but are not limited to: daycare, grooming, activities, boarding, medical care and late fees.
2. _____ **Paws At Play Resort & Daycare** is a cage-free facility. If my dog participates in daycare, I understand that an interactive play setting is not without some risk of injury, that despite all the dogs appearing healthy and being handled with the greatest amount of care and foresight, dogs are not always predictable, and the unexpected may occur. I recognize that the benefits of an interactive playgroup are valuable to my dog, and accept the potential risks. I further agree to pay veterinary/medical expenses incurred as a result of injury to or caused by my dog.
3. _____ If my pet appears to be ill, **Paws At Play Resort & Daycare** will first contact me to discuss concerns. If I am unavailable and the concerns are determined to be serious or life threatening, then I authorize **Paws At Play Resort & Daycare** to engage the services of the veterinarian-on-call, North Royalton Animal Hospital, at my expense, and all decisions will be made in the best interest of my pet's health. I agree to pay all veterinary charges incurred by my pet while in the care of **Paws At Play Resort & Daycare**. I will not hold **Paws At Play Resort & Daycare** liable for failure to seek veterinary attention or for decisions made under this contract. All reasonable attempts will be made to contact you immediately in the event of an emergency.
4. _____ I understand that **Paws At Play Resort & Daycare** will exercise all due diligence and care in the guardianship of my pet. I hereby waive and release, **Paws At Play Resort & Daycare**, its employees, owners and agents from any and all liability of any nature, for injury or damage, including that which may result from the action of any dog including my own. I expressly assume the risk of such damage or injury while my dog participates in or attends any function of **Paws At Play Resort & Daycare** while on the grounds or the surrounding area thereto.
5. _____ I understand that I am required to provide **Paws At Play Resort & Daycare** documented records and to keep the vaccination up-to-date for the duration of my dog participation at **Paws At Play Resort & Daycare**. These vaccines include DA2PP, Rabies, Bordetella, Canine Influenza (H3N8), and Lepto. Must have a negative fecal sample every 6 months and be on veterinary approved flea and heartworm prevention. Failing to meet these requirements will result in immediate dismissal from the facility.
6. _____ All dogs must be at least 4 months of age or older. All dogs over the age of 7 months must be spayed or neutered. Puppies and rescue dogs must be in the home for 1 month prior to coming to daycare.
7. _____ All dogs must be in good health. Owners will certify that their dog(s) are in good health and have not been ill with a communicable condition in the last 14 days. Upon admission, all dogs must be free of any condition that could potentially jeopardize other guests, including but not limited to upper respiratory infections, intestinal parasites and fleas. Dogs that have been ill with a communicable condition in the last 14 days will require veterinarian certification of health to be permitted to return. Owner will accept full financial responsibility for any and all expenses involved by our veterinarian-on-call at North Royalton Animal Hospital, when necessary.

- 8. Owners will need to certify that their dog(s) have not harmed or shown aggression or threatening behavior towards any person or other dog(s). Paws At Play Resort & Daycare reserve the right to refuse admittance to any dog that does not meet the requirements or dismiss any pet that exhibits threatening behavior.
9. Personal items such as toys are not permitted at daycare.
10. If a pet that is presented for daycare and is found to have fleas and/or ticks, it will be treated at the owner's expense by our veterinarian-on-call at North Royalton Animal Hospital.
11. Dogs are not fed during daycare hours to prevent resource guarding and fighting. If a pet needs to be fed for medical reasons, then this must be discussed and agreed upon in advance of attendance at daycare.
12. The center closes at 6:30 PM. Unless special arrangements have been made, there is a \$1.00 per minute charge for any dog left after 6:30 PM.
13. I expressly waive and relinquish any and all claims against Paws At Play Resort & Daycare, its employees and representatives, except those arising from negligence on the part of Paws At Play Resort & Daycare.
14. I have disclosed to Paws At Play Resort & Daycare all known dangers associated with my dog(s).
15. I expressly understand and agree that Paws At Play Resort & Daycare shall not be held responsible for any damage to my property, or that of others, caused by my dog(s) during the period in which they are in its care.

On behalf of myself and any and all other owners of this pet, I have read and agree to the terms of this contract.
